Judges for WC & WCX will be Marshall Richard and Claudia Norton. Co-Chairmen for the tests are Patti Sullivan and Susan Naylor.

Judging will begin promptly at 9:00 AM.

The order of tests is as follows: WCX Land, WC Land, WCX Water, WC Water.

Cross entries will NOT be allowed between WC & WCX.

WC/WCX tests will be run under GRCA Rules and Regulations, and are open to Golden Retrievers, Flat-Coated Retrievers, and Irish Water Spaniels. BITCHES IN SEASON MAY NOT RUN ANY TEST AND ARE NOT ALLOWED ON THE GROUNDS THE DAY OF THE TEST. Refunds will be given if a veterinary certificate is provided. Dogs must be at least 6 months old to enter.

Please note that game in WCX will be LIVE and freshly killed ducks on land and freshly killed ducks on water. Game will be freshly killed ducks in WC. GRCA rules allow for the possibility that WINGERS may be used in the WCX (not WC) test. WCX/WC Rules and Regulations are available on the GRCA website or upon request from the Test Secretary.

Pre-entries must be received by Wednesday, August 14, 2013. Same day entries will close at 9:00 AM with the test secretary at test headquarters.

CT Route 44 east, to Route 12

North on Route 12

Left onto West Thompson Road (at traffic light) at the intersection

of Route 12, 193 and West Thompson Road

Follow signs

## From the South:

I-395 North to exit 97

West on Route 44 to Route 12

North on Route 12

Left onto West Thompson Road (at traffic light) at the intersection of

Route 12, 193 and West Thompson Road

Follow signs

### From the North:

I-395 South to exit 99 Left onto Route 200 Right onto 193

Straight across Route 12 at traffic light You are now on West Thompson Road

Follow signs

Signs will be posted at major intersections.

# **VERY IMPORTANT REQUEST FOR YOUR COOPERATION:**

While using the property at West Thompson Lake, we are under the regulations of the US Army Corps of Engineers, whose primary focus is flood control and environmental stewardship. Our use is strictly limited to designated areas only. No other access or driving will be permitted. VEHICLES MUST BE DRIVEN ONLY ON THE ROADWAY, AND KEPT IN DESIGNATED PARKING AREAS OR WHERE DESIGNATED ALONG THE ROADSIDE. Speed limits must not exceed 10 mph anywhere in the park. THE GATE MUST REMAIN CLOSED THROUGHOUT THE EVENT, SO PLEASE CLOSE THE GATE WHENEVER YOU ENTER OR EXIT. Extra care should be taken to be courteous to other park users (hikers, walkers, bicyclists and horse riders). We do not have exclusive use of the park. Do not leave ANY litter behind and be careful with matches and smoking materials. Treat the land, its inhabitants and other visitors with respect, and be an ambassador for our sport. Failure to use good judgment will result in fines and denial of future permits for the entire field dog club.
